Complete all sections of this form that are applicable. Sections with superscript numbers 1 thru 5 must be completed to process your samples. Shaded areas are for internal use only.

Section (1): Please fill out CONTACT NAME, ADDRESS, TELEPHONE NUMBER, E-MAIL ADDRESS and COMPANY NAME to identify who will receive the report.

Indicate how you would like to receive your report, whether it is by MAILING ADDRESS, FAX or EMAIL.

Indicate PAYMENT type. Checks or Money Orders can be sent with sample, Call with your Credit Card info. Visa or Master Card only. For your protection, do not send cash through the mail. ***Before sending any sample please call for pricing and fees 928-443-5227***
